

**THIS SUPPLEMENTARY TRUST DEED** was made on **[Date]**

**BETWEEN**

Persons/ The entity named in Part I of the Schedule  
(Hereinafter referred to as the “Founder” on one part)

**AND**

Persons named in Part III of the Schedule  
(Hereinafter referred to as the “New Trustees” on the other part)

(The Founder and the New Trustees may be separately referred to as  
“Party” or collectively as “Parties”)

**RECITALS—**

- A. The Founder and the persons named in Part II of the Schedule (hereinafter referred to as “First Trustees”) have signed a trust deed dated **[Date of Principal Trust Deed]** to establish a trust named **[Name of Trust]** (hereinafter referred to a “Principal Trust Deed”).
- B. Clause/ Para **[Number of Clause/ Para That Provides for the Appointment/ Reappointment of Trustees]** of the Principal Trust Deed provides that **[State Provision Regarding Appointment/ Reappointment of Trustees]**.

The Founder and the New Trustees have agreed to supplement the Principal Trust Deed with this Supplemental Trust Deed to govern the appointment of the New Trustees as successor trustees upon and subject to the terms and conditions hereinafter contained and the modifications, changes and amendments to the Principal Trust Deed incorporated herein.

**NOW IT IS HEREBY AGREED** as follows:

**1. SUPPLEMENTAL**

- 1.1 This Supplemental Trust Deed is supplemental to the Principal Trust Deed and shall be read and construed as part of the Principal Trust Deed.
- 1.2 Unless otherwise stated in this Supplemental Trust Deed, the provisions in the Principal Trust Deed shall apply to this Supplemental Trust Deed.
- 1.3 In case of any contradiction or inconsistency between the provisions of this Supplemental Trust Deed and the Principal Trust Deed, the provisions of this Supplemental Trust Deed shall prevail to the extent of the contradiction or inconsistency.

**2. DEFINITIONS**

The Definitions adopted in the Principal Trust Deed shall apply in this Supplemental Trust Deed, unless otherwise expressly defined in this Supplemental Trust Deed or if the context requires a different meaning.

**3. EFFECTIVE DATE**

3.1. This Supplemental Trust Deed shall be deemed to be effective on **[Effective Date of Supplemental Trust Deed]**.

3.2. This Supplemental Deed and the Principal Trust Deed shall on the effective date deemed to be consolidated to form and read as one trust deed subject to the variations contained in this Supplemental Trust Deed.

#### **4. REAPPOINTMENT/ APPOINTMENT OF TRUSTEE(S)**

The New Trustees shall, on the effective date of this Supplemental Trust Deed, assume and act as the successor trustee(s) for the **[Name of Trust]** upon such terms and conditions as set out in the Principal Trust Deed except for any breach committed by the First Trustees/ previous trustees.
